## STATEMENT OF THE CASE

This is a simple post foreclosure Unlawful Detainer case which, is a summary proceeding and should not include, issues regarding the underlying loan or foreclosure process. DEUTSCHE BANK NATIONAL TRUST COMPANY acquired title to the subject real property, described as 3554 Lovebird Way, Antioch, CA 94509 on June 4, 2009 as a result of a foreclosure proceeding. Unlawful Detainer Defendants HERMENEGILDO J. CAPARAS AND JUANITA R. CAPARAS were served with the appropriate notice to quit on June 18, 2009. The notice expired and Unlawful Detainer Defendants HERMENEGILDO J. CAPARAS AND JUANITA R. CAPARAS refused to vacate the subject property. Attached hereto Exhibit "A" as a true and correct copy of the Trustee's Deed Upon Sale from which Plaintiff DEUTSCHE BANK acquired title to the subject real property. It reflects, that CAPARAS had a mortgage loan secured by a Deed of Trust that was recorded in the Contra Costa County Recorder's Office on July 19, 2006, as Instrument No. 2006-0227370-00, reflecting a fist loan in the principal sum of \$640,000.00. A true and correct copy of the first loan is attached hereto as Exhibit "B". addition to the first loan, CAPARAS also had a second loan obtained at the same time, memorialized by a Deed of Trust recorded in the Contra Costa Recorder's Office on July 19, 2006, the same date as the first loan, reflected as instrument numbers 2006-0227371-00 in the principal sum of \$160,000.00. A true and correct copy of the second loan is attached hereto Exhibit "C". The subject lawsuit completely ignores the second loan obtained at the exact same time as the first loan, in Case No. C 09-02048. The Demurrer filed in the Unlawful Detainer Case also completely ignores the second loan.

The Trustee's Deed Upon Sale attached hereto as Exhibit "A" also reflects, the time of the time of the foreclosure sale that took place on June 4, 2009, the amount paid by DEUTSCHE BANK NATIONAL TRUST COMPANY for the property was \$350,091.05.

# STATUS OF CAPARAS DEFENDANTS UNLIMITED JURISDICTION LITIGATION

At this time, Plaintiff herein, DEUTSCHE BANK NATIONAL TRUST COMPANY, and a Defendant in the Unlimited Jurisdiction case Demurrer is currently set for hearing on January 28, 2010. In addition, a number of Defendants in the Unlimited Jurisdiction case which seemingly are necessary and indispensable parties have been voluntarily dismissed by CAPARAS. In addition, other Defendants in the Unlimited Jurisdiction case still have not been served.

Plaintiff herein, DEUTSCHE BANK NATIONAL TRUST COMPANY, and Defendant in the Unlimited Jurisdiction case, currently has a Demurrer to the First Amended Complaint set for hearing on January 28, 2010. In addition, DEUTSCHE BANK NATIONAL TRUST COMPANY filed written opposition to both a Notice of Related Actions and Opposition to a Motion to Consolidate. The Motion to Consolidate was denied on November 19, 2009.

# STATUS OF SETTLEMENT DISCUSSIONS

On Friday, December 18, 2009, CAPARAS Defendants responded to a request made on behalf of DEUTSCHE BANK NATIONAL TRUST COMPANY that Defendants vacate the subject premises, stipulate surrender possession, in exchange for a waiver of costs and hold over damages. In response, Defendants CAPARAS submitted a letter dated December 18, 2009, a copy which is attached hereto as Exhibit "D". In essence, despite the CAPARAS' refusal, to acknowledge the tender obligation with regard to any claims attacking the foreclosure proceeding or otherwise, they are demanding, that a new loan be created, at ridiculous terms, and that the monthly payment be reduced to a sum completely ignoring the prior loan and subject property, as well as prior defaults.

It is the position of DEUTSCHE BANK NATIONAL TRUST COMPANY, that the Law Offices of Timothy McCandless on behalf of the CAPARAS Defendants herein and Plaintiffs in the Unlimited Jurisdiction case, are simply using the Judicial process for purposes of delaying the post foreclosure Unlawful Detainer proceeding. At no time, have the CAPARAS', or their counsel, ever offered any facts to support any financial viability on the part of CAPARAS, such as occupations, income, and or money

available to attempt to resolve any matter or, to pay any financial obligations. More particularly, the CAPARAS Defendants completely ignore obligations with regard to real property taxes and maintenance of home owners insurance for the subject property while they continue to use it rent free.

# SETTLEMENT POSITION OF PLAINTIFF DEUTSCHE BANK NATIONAL TRUST COMPANY

Plaintiff DEUTSCHE BANK NATIONAL TRUST COMPANY, simply demands that the CAPARAS Defendants stipulate to a Judgment of Possession and vacate the property by January 15, 2010 in exchange for waiver of holdover damages. The CAPARAS Defendants are free to litigate their action currently pending in the Superior Court Unlimited system. DEUTSCHE BANK NATIONAL TRUST COMPANY makes no condition with regard to any matters in the Unlimited Jurisdiction Court in seeking to resolve this Unlawful Detainer proceeding



Lender shall apply the Funds to pay the Escrow Items no later than the time specified under RESPA. Lender shall not charge Borrower for holding and applying the Funds, annually analyzing the escrow account, or

To the extent that these items are Escrow Items, Borrower shall pay them in the manner provided in Section 3.

Borrower shall promptly discharge any lien which has priority over this Security Instrument unless Borrower: (a) agrees in writing to the payment of the obligation secured by the lien in a manner acceptable to Lender, but only so long as Borrower is performing such agreement; (b) contests the lien in good faith by, or defends against enforcement of the lien in, legal proceedings which in Lender's opinion operate to prevent the enforcement of the lien while those proceedings are pending, but only until such proceedings are concluded; or (c) secures from the holder of the lien an agreement satisfactory to Lender subordinating the lien to this Security Instrument. Lender or its agent may make reasonable entries upon and inspections of the Property. If it has reasonable cause, Lender may inspect the interior of the improvements on the Property. Lender shall give Borrower notice at the time of or prior to such an interior inspection specifying such reasonable cause.

- 8. Borrower's Loan Application. Borrower shall be in default if, during the Loan application process, Borrower or any persons or entities acting at the direction of Borrower or with Borrower's knowledge or consent gave materially false, misleading, or inaccurate information or statements to Lender (or failed to provide Lender with material information) in connection with the Loan. Mortgage Insurance reimburses Lender (or any entity that purchases the Note) for certain losses it may incur if Borrower does not repay the Loan as agreed. Borrower is not a party to the Mortgage Insurance.

Mortgage insurers evaluate their total risk on all such insurance in force from time to time, and may enter into agreements with other parties that share or modify their risk, or reduce losses. These agreements are on terms and conditions that are satisfactory to the mortgage insurer and the other party (or parties) to these agreements. These agreements may require the mortgage insurer to make payments using any source of funds that the mortgage insurer may have available (which may include funds obtained from Mortgage Insurance premiums).

As a result of these agreements, Lender, any purchaser of the Note, another insurer, any reinsurer, any other entity, or any affiliate of any of the foregoing, may receive (directly or indirectly) amounts that derive from (or might be characterized as) a portion of Borrower's payments for Mongage Insurance, in exchange for sharing or modifying the mortgage insurer's risk, or reducing losses. If such agreement provides that an affiliate of Lender takes a share of the insurer's risk in exchange for a share of the premiums paid to the insurer, the arrangement is often termed "captive reinsurance." Further:

- (a) Any such agreements will not affect the amounts that Borrower has agreed to pay for Mortgage Insurance, or any other terms of the Loan. Such agreements will not increase the amount Borrower will owe for Mortgage Insurance, and they will not entitle Borrower to any refund.

otherwise agree in writing, the Miscellaneous Proceeds shall be applied to the sums secured by this Security Instrument whether or not the sums are then due.

If the Property is abandoned by Borrower, or if, after notice by Lender to Borrower that the Opposing Party (as defined in the next sentence) offers to make an award to settle a claim for damages, Borrower fails to respond to Lender within 30 days after the date the notice is given, Lender is authorized to collect and apply the Miscellaneous Proceeds either to restoration or repair of the Property or to the sums secured by this Security Instrument, whether or not then due. "Opposing Party" means the third party that owes Borrower Miscellaneous Proceeds or the party against whom Borrower has a right of action in regard to Miscellaneous Proceeds.

- 12. Borrower Not Released; Forbearance By Lender Not a Waiver. Extension of the time for payment or modification of amortization of the sums secured by this Security Instrument granted by Lender to Borrower or any Successor in Interest of Borrower shall not operate to release the liability of Borrower or any Successors in Interest of Borrower. Lender shall not be required to commence proceedings against any Successor in Interest of Borrower or to refuse to extend time for payment or otherwise modify amortization of the sums secured by this Security Instrument by reason of any demand made by the original Borrower or any Successors in Interest of Borrower. Any forbearance by Lender in exercising any right or remedy including, without limitation, Lender's acceptance of payments from third persons, entities or Successors in Interest of Borrower or in amounts less than the amount then due, shall not be a waiver of or preclude the exercise of any right or remedy.
- 13. Joint and Several Liability; Co-signers; Successors and Assigns Bound. Borrower covenants and agrees that Borrower's obligations and liability shall be joint and several. However, any Borrower who co-signs this Security Instrument but does not execute the Note (a "co-signer"): (a) is co-signing this Security Instrument only to mortgage, grant and convey the co-signer's interest in the Property under the terms of this Security Instrument; (b) is not personally obligated to pay the sums secured by this Security Instrument; and (c) agrees that Lender and any other Borrower can agree to extend, modify, forbear or make any accommodations with regard to the terms of this Security Instrument or the Note without the co-signer's consent.

Subject to the provisions of Section 18, any Successor in Interest of Borrower who assumes Borrower's obligations under this Security Instrument in writing, and is approved by Lender, shall obtain all of Borrower's rights and benefits under this Security Instrument. Borrower shall not be released from Borrower's obligations and liability under this Security Instrument unless Lender agrees to such release in writing. The covenants and agreements of this Security Instrument shall bind (except as provided in Section 20) and benefit the successors and assigns of Lender.

14. Loan Charges. Lender may charge Borrower fees for services performed in connection with Borrower's default, for the purpose of protecting Lender's interest in the Property and rights under this Security Instrument, including, but not limited to, attorneys' fees, property inspection and valuation fees. In regard to any other fees, the absence of express authority in this Security Instrument to charge a specific fee to Borrower shall not be construed as a prohibition on the charging of such fee. Lender may not charge fees that are expressly prohibited by this Security Instrument or by Applicable Law.

If the Loan is subject to a law which sets maximum loan charges, and that law is finally interpreted so that the interest or other loan charges collected or to be collected in connection with the Loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note or

15. Notices. All notices given by Borrower or Lender in connection with this Security Instrument must be in writing. Any notice to Borrower in connection with this Security Instrument shall be deemed to have been given to Borrower when mailed by first class mail or when actually delivered to Borrower's notice address if sent by other means. Notice to any one Borrower shall constitute notice to all Borrowers unless Applicable Law expressly requires otherwise. The notice address shall be the Property Address unless Borrower has designated a substitute notice address by notice to Lender. Borrower shall promptly notify Lender of Borrower's change of address. If Lender specifies a procedure for reporting Borrower's change of address, then Borrower shall only report a change of address through that specified procedure. There may be only one designated notice address under this Security Instrument at any one time. Any notice to Lender shall be given by delivering it or by mailing it by first class mail to Lender's address stated herein unless Lender has designated another address by notice to Borrower. Any notice in connection with this Security Instrument shall not be deemed to have been given to Lender until actually received by Lender. If any notice required by this Security Instrument is also required under Applicable Law, the Applicable Law requirement will satisfy the corresponding requirement under this Security Instrument.

16. Governing Law; Severability; Rüles of Construction. This Security Instrument shall be governed by federal law and the law of the jurisdiction in which the Property is located. All rights and obligations contained in this Security Instrument are subject to any requirements and limitations of Applicable Law. Applicable Law might explicitly or implicitly allow the parties to agree by contract or it might be silent, but such silence shall not be construed as a prohibition against agreement by contract. In the event that any provision or clause of this Security Instrument or the Note conflicts with Applicable Law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision.

As used in this Security Instrument: (a) words of the masculine gender shall mean and include corresponding neuter words or words of the feminine gender; (b) words in the singular shall mean and include the plural and vice versa; and (c) the word "may" gives sole discretion without any obligation to take any action.

- 17. Borrower's Copy. Borrower shall be given one copy of the Note and of this Security Instrument.
- 18. Transfer of the Property or a Beneficial Interest in Borrower. As used in this Section 18, "Interest in the Property" means any legal or beneficial interest in the Property, including, but not limited to, those beneficial interests transferred in a bond for deed, contract for deed, installment sales contract or escrow agreement, the intent of which is the transfer of title by Borrower at a future date to a purchaser.

If all or any part of the Property or any Interest in the Property is sold or transferred (or if Borrower is not a natural person and a beneficial interest in Borrower is sold or transferred) without Lender's prior written consent, Lender may require immediate payment in full of all sums secured by this Security Instrument. However, this option shall not be exercised by Lender if such exercise is prohibited by Applicable Law.

If Lender exercises this option, Lender shall give Borrower notice of acceleration. The notice shall provide a period of not less than 30 days from the date the notice is given in accordance with Section 15 within which Borrower must pay all sums secured by this Security Instrument. 19. Borrower's Right to Reinstate After Acceleration. 



- 3. Application of Payments. Unless applicable law provides otherwise, all payments received by Lender under the Note and paragraphs 1 and 2 hereof shall be applied by Lender first in payment of amounts payable to Lender by Borrower under paragraph 2 hereof, then to interest payable on the Note, and then to the principal of the Note.

As used herein, "costs," "expenses" and "attorneys' fees" include all sums to the extent not prohibited by applicable law or limited herein.
- 14. Borrower's Copy. Borrower shall be furnished a conformed copy of the Note and this Deed of Trust at the time of execution or after recordation hereof.
- 15. Rehabilitation Loan Agreement. Borrower shall fulfill all of Borrower's obligations under any home rehabilitation, improvement, repair, or other loan agreement which Borrower enters into with Lender. Lender, at Lender's option, may require Borrower to execute and deliver to Lender, in a form acceptable to Lender, an assignment of any rights, claims or defenses which Borrower may have against parties who supply labor, materials or services in connection with improvements made to the Property.
- 16. Transfer of the Property or a Beneficial Interest in Borrower. If all or any part of the Property or any interest in it is sold or transferred (or if a beneficial interest in Borrower is sold or transferred and Borrower is not a natural person) without Lender's prior written consent, Lender may, at its option, require immediate payment in full of all sums secured by this Deed of Trust.
